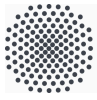

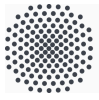

2. The admission will stand cancelled if any of the documents or declarations submitted by you are found incorrect or false.

In case, of carryover of backlog/ATKT, you will be offered the provisional admission and allowed to join the course. However, you are required to clear the backlog with documentation proof in the time specified by NICMAR University, Pune i.e., on or before September 30, 2023. You will also have to furnish all the required academic marksheets / certificates including your bachelor's degree mark sheet by the stipulated time mentioned above. If you fail to clear the backlog within the specified time, you will have to discontinue the course at NICMAR University, Pune.

Congratulations, you have been accepted into the Computer Science Master's program at California State University, Chico. Your admission status is *conditionally classified*. This means, you will officially be a full time graduate student, will be able to get a student visa, but you will have to take two prerequisite courses. Once you complete the prerequisite courses you will be able to take master's courses.

Our master's program is designed to prepare students for careers in the American software industry. Our graduates are well prepared for a range of software jobs and have productive and successful careers. The success of our alumni is due in part to the applied nature of our program. Students write a significant amount of software in addition to learning about theoretical aspects of computer science.

The master's program consists of four required graduate courses (Applied Machine Learning, Software Design and Maintenance, Algorithms and Computability, and Research Methods in Computer Science), two elective graduate courses (e.g. Applied Web Technology, Applied Graph Theory, Applied Computer Vision, Operating Systems, Topics in Artificial Intelligence), and four elective courses (courses are available in a wide range of topics including security, machine learning, artificial intelligence, mobile applications, object-oriented programming, compiler construction, and networking). The current University Catalog is out of date. This summer the Fall 2022 catalog will be published and will contain up-to-date descriptions of the program and the courses.

Our master's program allows students to complete a master's thesis if they choose, but almost all our students choose to take our Research Methods in Computer Science course. This one semester course replaces the thesis, project, and exam options at most universities. It interweaves three distinct themes (investigation, experimentation, and technical writing), that culminate in a comprehensive research project and a presentation. It is significantly less work than a master's thesis and master's project. Students with a strong research focus can replace the Research Methods course with a master's thesis or master's project.

Because of the applied nature of our program, it is important that students have a very strong programming background. Students without an ABET accredited computer science bachelor's degree are required to take accelerated versions of our second and third C++ programming courses (CSCI 211 and CSCI 311). You will complete both of these courses in one semester. These are difficult courses that will prepare you for our graduate courses and for careers in the American software industry. These courses will not count toward your master's degree. While these courses may seem unnecessary, most of our graduates report that the strong programming skills they learned from prerequisite courses helped to qualify them for their current employment. Our current graduate students, most of whom have computer science undergraduate degrees, report that they learned a lot from these courses and think they should remain prerequisites to the master's program.

After the first semester you will complete the 10 master's courses. It will take a total of 4 semesters to complete all prerequisite classes and the master's degree.
